confidence should be tabled calling the special general meeting within one month of obstinance.

- (b) The special general meeting held to discuss the motion of vote of no confidence, it should consider favor and opponent opinion of vote of no confidence and concerning Executive Committee and official and difference statement of member.
- (c) If 2/3 members out of total members of the general meeting vote in favor of the vote of no confidence then vote of no confidence shall be passed and after passing the vote no confidence on such way the concerning member and official shall be removed from the post as the consequences.
- (d) If the vote of no confidence motion is registered against the president then by the vice-president, if the vote of no confidence motion is registered against president and vice-president then by the senior member of the Executive Committee and if vote of no motion is registered against the all Executive Committee then the senior member presented in the special general meeting shall chair (the meeting).
- (e) After registration of motion of vote of no confidence, there should be provided the opportunity of clearance to such Executive Committee and official and member.

21. Amendment of the constitution :- After making approval by the 2/3 members out of total number members then to amend any section or to repeal, it should be forwarded making recommendation to the local authority. After getting approval by the local authority then any section of the organization shall be regarded as amended or repealed.

- (a) If there need any amendment to be done in this constitution then it should be purposed to all members giving at least 15 days written notice along with purpose of the amendment before holding the general meeting by the Executive Committee.
- (b) The purposed amendment constitution proposal should be passed by the 2/3 of majority of members of the organization presenting in the meeting.
